RE: Shortage of SEPTRIN sugar-free oral liquid, trimethoprim 40 mg/5 mL and sulfamethoxazole 200 mg/5 mL, 100 mL bottle and alternative supply arrangement under Section 19A of the *Therapeutic Goods Act*.

Dear Healthcare Professional,

This notification is sent by LINK to inform your organisation that due to the shortage of Australian registered SEPTRIN sugar-free oral liquid, trimethoprim 40 mg/5 mL and sulfamethoxazole 200 mg/5 mL, 100 mL bottle (AUST R 11000), LINK has arranged the supply of an alternative product, Co-Trimoxazole 40 mg/200 mg per 5 ml Paediatric Suspension (Aspen) registered and marketed in the United Kingdom.

**Co-Trimoxazole 40 mg/200 mg per 5 ml Paediatric Suspension (Aspen)** is NOT registered in Australia and supply is authorised under an exemption granted by the Therapeutic Goods Administration (TGA) under Section 19A of the *Therapeutic Goods Act, 1989* until **31 August 2022.** 

**Co-Trimoxazole 40 mg/200 mg per 5 ml Paediatric Suspension (Aspen)** is approved for use under Section 19A for the following indications:

Upper and lower respiratory tract infections; renal and urinary tract infections; genital tract infections; gastrointestinal tract infections; skin and wound infections; septicaemias, and other infections caused by sensitive organisms.

The s19A approved *UK* product is identical in active ingredient and strength to the Australian registered product. The two products differ in their storage conditions and excipient ingredients. These differences are noted below:
