'In particular, we look forward to expanding opportunities for pharmacists in primary care to prevent avoidable hospital admissions in a constrained system, and embedding pharmacists into aged care facilities from 2023, as key areas of collaboration.

'Central to these are ongoing workforce capacity and sustainability issues. I know that, as a university lecturer, Dr Sim is cognisant of the issues facing our early career pharmacists and pharmacy students.

'I would also like to congratulate Michelle Lynch on her reappointment as Vice President, and Past-President Dr Shane Jackson as Vice President, both of whom are passionate about advancing the pharmacy profession.

'Finally, I extend a warm farewell to Associate Professor Chris Freeman, who has steered PSA through a challenging time for the Australian healthcare system amid the COVID-19 pandemic, and achieved many significant outcomes for pharmacy research and aged care pharmacy services, as well as elevating recognition of medicines safety as a National Health Priority Area.'
